1. COST/PAYMENT

- A.** Cost, as indicated above is due before the dog is shipped or received.
- B.** A non-refundable deposit of half entire price is required to hold any dog, but no more than 30 days.
- C.** If the dog is not paid in full by the above time they will be placed back for sale and the deposit will NOT be refunded but may be transferred to another pup of equal value.
- D.** For puppies that ear cropping an option Ear cropping is available for an additional cost of \$600.00, seller will schedule appointment with Howertons Animal Hospital Vet Clinic 417-532-3811. Seller is not to be held liable for anything related to the crop. If the dog should pass during the procedure a replacement puppy will be offered however no refund.

2. OWNERSHIP

- A.** When introduced into new surroundings dogs are sometimes inclined to exhibit shyness and inactivity. In some cases, they may refuse to eat. After becoming adapted to their homes, they will readily accept you as their new master and overcome the shyness of the new quarters. You as the new owner have a great responsibility to maintain your dog's emotional and physical well-being.
- B.** The puppy is not to be Co-owned, given, or shared ownership with anyone without signing and agreeing to this contract of sale and with written permission from seller.
- C.** If the dog is ever picked up by animal control or any form of law enforcement the dog must be returned to the breeder at cost of new owner.
- D.** If buyer decides to sell the dog, it must be offered back to the breeder first. This is for the life of the dog regardless of how much money has been spent on the dog. If breeder declines to purchase the dog back at the price sold for originally, then said dog may be sold at the buyer's discretion. With new buyer agreeing to same contract, and Puppies 4 Everyone contact information given to them.
- E.** The dog must never be abused, neglected, mistreated, used for research, or used for any illegal purposes such as Dog Fighting, etc. If it is found that the above dog is placed in the above situation the dog must be returned to the seller along with all registration and ownership.
- F.** Buyer hereby agrees to keep the initials P4E in front of the above purchased dog's registered name for the entire life of the dog, regardless of sale or gift. Unless other arrangements have been arranged with seller. This is to show where the puppy was produced.
- G.** Buyer certifies that he/she is not acting as an agent for another individual in the purchase of this dog and will not sell to a puppy mill.
- H.** The Buyer agrees to stay in contact with the Seller and inform Seller of any changes in the dog's home such as the buyer moves. The Buyer also agrees to keep Seller posted with updated photos/health of the pup.

3. HEALTH

- A.** At the expense of the BUYER, a licensed veterinarian MUST examine this dog within 72 hours of possession to validate health guarantee. (If purchased on a weekend, this requirement is extended through the following Monday.)
- B.** Seller guarantees this dog to be current on age-appropriate vaccinations, dewormings, and in good health. Puppies will have current veterinary Health Certificate done within 48 hours of delivery. Puppies will be dewormed at 2,3,4,6, & 8 weeks and a 5-way vaccine given at 6 weeks and a 7-way vaccine given at 8 weeks by Puppies 4 Everyone. A normal deworming and vaccination schedule should be followed as recommended by your veterinarian and must remain current for the lifetime of the dog.
- C.** If pup is found to have any congenital or hereditary illnesses (before 12 months) that seriously impacts the puppy's quality of life, the buyer agrees to inform the seller in a written statement by a licensed Vet immediately, Puppies 4 Everyone will replace the pup (with a pup of EQUAL

value by the choice of the breeder out of next available breeding) provided the condition is sufficiently serious in the opinion of two qualified veterinarians. Puppies 4 Everyone DOES NOT give cash refunds for any reason or a higher pick puppy. Buyer agrees to pay any and all veterinarian charges and shipping charges until returned to breeder. The registration papers and puppy must be returned to Puppies 4 Everyone before the pup will be replaced.

D. Giant Schnauzers tend to be more prone to bacterial, viral, staff and fungal infections as well as various forms of Dermatitis, Allergies, Demodex and Color Mutant Alopecia. While some of these conditions are hereditary many of them are simply the result of chance. We personally have done a lot of research and discussed this with our Vet and as a result of our findings and the opinions of our Vets we do not guarantee against any skin or coat problems. Nor will we be responsible for skin and coat problems that are common for dogs with any coat coloring. Most of these coat problems are easily and inexpensively treated. Most breeders will not tell you about these common problems, but we feel it is your right to know. We have seen it produced in all bloodlines however we do not breed dogs with issues themselves. Most dogs will not be affected by a skin problem, but you must be prepared to treat your dog in the event that it does. We will not knowingly breed any dog that is a producer of a skin disease, but there is no test available for these problems prior to signs of infection. Adult dogs can be carriers and not ever show signs of infection. For more information on this, please discuss this with your Vet and research it online or elsewhere as we have, before you decide to buy to a pup/dog. We will not replace a dog or refund money on a dog purchased from us that becomes affected by Demodectic Mange or any other coat related illness.

E. If death is caused by accident or poisoning, purchase price will not be refunded. The breeder will not be responsible for any Vet bills or other bills that may incur after the purchase of the dog.

F. Clean water must be always available, adequate quality food must be given, and animal must be kept in a clean and secure enclosed yard or large kennel with appropriate amount of shade and shelter when not inside the home.

G. If at any time during ownership the local law enforcement/animal control feels that the dog is not being properly cared for, the breeder has the option to confiscate the dog immediately and without any compensation due to buyer, and full registration paperwork must be signed and given back to breeder.

H. Puppies are not to be spayed/neutered before 1 year (12 months) of age but preferably not after 2 years (24 months) of age. We will not replace a dog or refund money due to health problems associated with early spay/neutering.

I. The Health Guarantee expires completely and entirely after one year of age. In no cases will pups/dogs be replaced with one of greater value without difference being paid by buyer. Non life threatening conditions or conditions which can be easily treated are also not covered by this guarantee.

4. BREEDING

A. Dog being purchased must never be bred to any other dog unless it's a PUREBRED, REGISTERED, and of the SAME BREED

B. Females may never be bred before their second heat and/or before 18 months of age, whichever occurs first and males must be one year of age before bred.

C. In the event a buyer decides to breed said dog, the buyer will take all necessary precautions to ensure a healthy quality litter.

5. ILLEGAL PURPOSES

A. All dogs from breeder must never be used for ANY illegal purposes.

B. If dog is used for illegal purposes it will be immediately removed from the home and all registration papers must be signed and forfeited to breeder. Criminal charges will then be filed with the proper-authorities.

C. This includes but is not limited to fighting, rolling, or facing off a dog with any other animal or dog.

6. SELLER GUARANTEES

- A. Seller guarantees the said dog is a purebred and is the offspring of the previously mentioned Sire and Dam.
- B. Seller DOES NOT guarantee the color or size of the said dog.
- C. We do NOT guarantee that the above dog is of show or breeding quality.
- D. If buyer champs this puppy/dog they will receive a 10% discount to a future puppy.

No other warranties are expressed or implied other than that which is stated above, if you choose not to take your puppy to a licensed vet in the time stated above this guarantee is void. If ANY part of this contract is broken, the FULL ownership, including signed registration, and possession of the dog will be returned to the breeder at the cost of buyer. The undersigned buyer acknowledges that this is a legal and binding contract and will be bound by the laws of Missouri and has received a copy. If this contract is broken and dog is not returned to breeder with signed registration papers the buyer will be liable for civil damages in the amount of \$2500, and that any dispute regarding this contract will be settled in the Missouri court at the cost of the buyer. This contract here by gives the breeder permission to repossess said dog if any part of this contract is broken. Buyer releases Seller, Puppies 4 Everyone and their estate from any and all liabilities, and/or damages by fault of this dog at the time of sale. These damages include but are not limited to, destruction of property and/or physical damage to any person or group of people. Buyer agrees to the entire contract and any other contracts attached.
